Bids must be placed in the tender box situated at the Supply Chain Management department, Municipal Building, Cnr Du Preez and H F Verwoerd Streets, Heidelberg which is accessible during office hours: Monday-Friday, 08:00-16:00 on or before **12:00, 12 February 2018. No late, no-emailed or no faxed bids will be considered.** All objectives and complaints must be lodged within 14 days and in writing to the municipal manager’s office.

Only bidders who score 70 points or more for functionality will be further evaluated on Price and BBBEE.

The 80/20 preference procurement point system will apply and preference will be given to bidders who are able to demonstrate the following:

All service providers must submit their B-BBEE Verification Certificate from Verification Agencies accredited by the South African Accreditation Systems (SANAS) or a Registered Auditor approved by the Independent Regulatory Board (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) in order to claim preference points.

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder’s tax obligations. Additionally, no contract shall be concluded with any bidder, whose municipal rates and taxes and service charges are in arrears. All bidders must ensure that they are registered on the National Treasury Central Supplier Database via the following link: www.csd.gov.za. No business will be conducted with any person who is not registered on this database.
