Bids completed in pencil will be regarded as invalid bids and the use of tippex are strictly prohibited. All objections and complains must be lodge within 14 days and in writing to the municipal's managers office.

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations. Bidders may be called by the municipality for a presentation. Additionally no contract shall be concluded with any bidder whose municipal rates and taxes and service charges are in arrears.
