Bids must be placed in the Tender Box situated at the Development and Planning Department, Municipal Building, c/o Du Preez and H F Verwoerd Street, Heidelberg which is accessible during office hours: Monday-Friday, 07:30-16:00 on or before **12:00, 31 August 2009 (closing date)**. **No late, no-emailed or no faxed bids will be considered.**

Bidder's attention is specifically drawn to the provisions of the rules which are included in the bid documents. The Council reserves the right to accept any bid or part thereof and does not bind itself to accept the lowest or any bid not suitably endorsed or comprehensively completed. Bids completed in pencil will be regarded as invalid bids.
